While her fiancé hails from a highly wealthy family, the main character is from a very modest background. Moreover, the quarter life crisis hits the male character seriously which led him to a big problem.

The researcher chose this novel because it delves into the theme of inequality between a rich and poor family in the context of a wedding which concerns powerful exploration of societal disparities and human emotions. Inequality is an ever-present issue in our world, and literature has always served as a mirror reflecting the complexities of such disparities. This novel's focus on a wedding setting provides a unique and intimate backdrop, as weddings symbolize not only a joyous occasion but also a convergence of different social classes, traditions, and expectations.

Moreover, this novel also discusses about quarter-life crisis which is relevant contemporary society and the personal struggles many individuals face in their early adulthood. In today's fast-paced and competitive world, young adults often find themselves grappling with immense pressure to make life-changing decisions. It provides a rich and nuanced portrayal of the internal battles faced by its characters as well. It delves into the emotional turmoil and self-doubt that arise when expectations clash with reality.

From the explanation stated, the researcher is interested in conducting a research entitled "The Elements of Fiction in Shopaholic Ties The Knot Novel".

The most crucial components of any literary work, including novels, are those that are story facts. People usually call story facts as intrinsic and extrinsic elements. A literary work's imaginative components are known as its story facts. Stanton (2007: 20) categorizes story fact into six namely 1) title; 2) theme; 3) plot; 4) characters; 5) setting; 6) and symbolization.

c. Method

Character refers to the person who portrays the character in the story whereas characterization describes the character or the character of the character (Nurgiyantoro, 2013). After analyzing the data, the researcher found 11 characters in the novel. There are two main characters of the novel namely Rebecca Bloomwood and Luke Brandon. Setting

Symbolization

On the other hand, the minor theme is societal expectations. The novel subtly touches on societal expectations, particularly those related to weddings, gender roles, and career choices. Becky feels pressure to meet these expectations, but she also challenges and subverts them in her own unique way. The theme reflects the societal pressures and expectations individuals often face in various aspects of their lives.

Discussion
